

PARKS, RECREATION & PUBLIC PROPERTY COMMITTEE MEETING
JULY 5, 2018
6:00 PM

Councilman Johnathan Hyde called the Parks, Recreation and Public Property meeting to order.

Roll call was taken and the following members were present: President Nicole Houck, Vice President Sean Steeg, Councilman James Bair Jr., Councilman Johnathan Hyde, Mayor David Wessels, and Borough Manager Daniel Varner.

Richard King took the minutes of this meeting.

Visitors present: Linda DeArmitt

Councilman Johnathan Hyde asked Linda DeArmitt if she had any comments and she did not.

Councilman Hyde spoke on the meeting the Parks & Recreation Commission had.

- Councilman Hyde stated that they have talked to DCNR about a grant next year and how to secure it.
- Councilman Hyde stated that they talked about the trail ways and assess ability and having 4 categories. He mentioned that not one person can do it and need 2 to 4 people.
- Dan Varner stated that he will get Donald Rupert and his guys to mow the trails and cut tree limbs.
- It was mentioned about the Dog Park fencing and poles are paved around and in concrete and if we cut at ground we will need to do something for safety.
- There was no update on the permit for the dog park and bulk water station.
- Dan Varner stated that he met with Melvin Isett, Chet Isett and Mary Ann Buckley about the Kiddy Pool Design. He said there are plans from Cisney & O'donnell and Rain Drop. It was questioned on whether this needs to be bid out and the committee said no due to be private money.
- Dan Varner said that we don't need to pay any Engineer when the Company that makes the equipment gives you a set of plans.
- Dan Varner said that he will be reaching out to Elks, Moose, Legion and VFW for donations.
- Dan Varner stated that he spoke with George Zanic about Blair Field and George asked the borough not to make any permanent decision until a final location for HAHS Baseball is determined.

- City League does not exist in its previous form, the people involved have changed. Mike Alexander is currently the President of the City League. The field was to be used by a softball co-ed
- It was mentioned about having a portable mound so the City League, High School and Softball can use the field.
- It was mentioned that the little Library post have been installed at Weaver Park.
- Dan Varner stated that the Park Maintenance was done at Portstown Park and Recycling Road by removing trees and limbs that fell by the recent storm.
- Dan Varner stated the Episcopal Church wants to take care of the merge garden at 8th & Mifflin Street and will take care of it until further notice. They will plant the flowers etc.
- Dan Varner spoke on the Air Conditioning and he called Jimmy Burkey after Berrena's didn't come.
- Dan Varner stated that he has requested to have the carpets cleaned.
- Councilman James Bair Jr., mentioned that he would like to see us get rid of the towel dispensers and get air handlers.
