Chairperson Bair called the meeting to order.

**RECOGNITION OF GUESTS AND PUBLIC COMMENT:** Jim Cassatt asked what is going on with the sinkhole at Crawford Apts. Why don't we contact them? Chairperson Bair responded that Manager Wheeler spoke with the Housing Authority. Manager Wheeler responded that it is entirely the Borough's problem. Manager Wheeler stated that he is renting a commercial fence for safety in the area.

Caleb Parnell was present to give an update on the cycling event. He reported that everything is in place.
